9. Youth Band - Paul McLaughlin

At this point Paul arrived and discussion followed as to why the GYBB had collapsed, how it had been run and what the carrot was for the children attending.

- GM was running lots of joint projects including Cotswold Edge and the Leap Project where there were a lot of children in attendance.
- GYBB had had 2 feeder bands but due maybe to the irregularity of the courses the bands didn't feed through as they should.

- The question was asked how the Cory Academy was run as it seemed to take from local training bands and then return them afterwards.
- Perhaps a venue such as Cheltenham Town Hall or the Youth Championships of Great Britain would be a carrot, the former possibly gaining some funding from the hub.
- Lydbrook, Lydney and City of Bristol Training were happy to form a nucleus for a concert and let others sit in.
- The question was raised whether Saturday Morning Music Centres would give half an hour of time to a brass event. Phil Storer and Katriona Windows to be contacted.
- Comments had been received that events were always in Gloucester and could courses be moved around the county.
- Noted that GBBA was a mis-noma in that it covered Hereford, Wiltshire, Somerset, Worcester as well as Gloucester. All to be contacted.

Paul was keen to address these issues and talk to people in band rooms which Committee felt they could not do for fear of poaching accusations. **PM**

10.WEBBA AM & next meeting 1st October 2017

There had been no appeals from the GBBA Area regarding Gradings.

The Forum was to meet on May 13th. RM asked who attended the Forum — Secretary Sue Oldfield. Felt an elected Council Member should attend.

The question of Kapitol taking charge of Area dates had been sent. RM asked what else was to be raised at the Forum and whether SO would be able to answer on Council's behalf. She had attended several with Brian Elliott previously and was aware how the Forum worked. A list of questions to be raised had not been forwarded to the Council beforehand.

The question of poor Area prize money which has not increased for years was raised. It was currently less than the entry fee to the Nationals.

Kapitol's accounts were not available for scrutiny so bands unaware whether they could afford a higher prize or to allow entry to Nationals for free.

The registry fees had also risen steeply this year by 100% and in some cases 170%. This had passed by with bands not raising the issue as they had to pay to compete at the Area.
